# Thoughts from your District Governor ....

When I joined the Lions Club I was told that it is a volunteer organization that supported multiple charities. Right after joining, I volunteered to be our club president. The next year I volunteered to be a zone chairperson. The next year I volunteered to be a treasurer. The next year I volunteered to help with SightFirst Two. The next year I volunteered to become the second vice district governor. All this time, I thought everyone volunteered like me.

As you may or may not remember, I challenged all to create 8 new clubs in our district and to bring in 450 new members. The reason I did this is because the most common complaint I heard was decreasing membership and our aging membership. Every club I visited said they needed new YOUNGER members. I really did believe everyone would jump at the chance to get new members.

You may or may not know that all of the Governors in Texas communicate with each other. I bring you good news. The Texas membership is growing. I got word that district T2 (Governor Peg White) will start three new clubs this week. I also heard that district S-4 (Governor Jeanie Cobb) will have as many as eight new clubs before the year ends. If they are successful, then they could be bigger than us, even though we have the biggest city in the nation's south within OUR district. District E2 is starting several new clubs up around Dallas (Governor John Paul Burnett).

Now I am sure that our district's volunteers have heard the call. I have extended the invitation to our members at EVERY President's and Secretary's Council meetings for volunteers to help canvas. I have sent several email invitations to just about everyone in the district who has an email address and asked for Lion volunteers. We have over seventeen-hundred Lion members in this district, yet I only received a total of only nine positive replies. I am left to wonder just how we can help our clubs needing to bring in new members if we can't get support from strong Lion leaders from across the district.

Presently, we are 21 members down from the start of this Lions year. I'm told repeatedly by Lions in the communities that WE NEED TO CANVAS FOR NEW MEMBERS! Our smaller clubs NEED the help of other Lions. It is not too late to turn this around. There are several club-assist programs scheduled over the next few weeks and I would really like to extend the hand of service to each of you to consider helping us rebuild some of our clubs.

The words of Helen Keller are truly applicable here – "alone we can do so little". So, I ask for you to help me, help our clubs canvas for new members. Hey, if a blind guy like me can do it, then I know YOU can do it. We have sixty two clubs now. I have challenged each club to find just eight new members. That can't be impossible, can it?

We are preparing for the second organizational meeting for the new Kingwood Lions Club. We NEED to have seven new clubs formed over the next 4 to 6 months. I'm also looking for good Lions to volunteer to serve as their Guiding Lion.



As is stands now, we have three clubs that need us.... the Oak Forest Club, the






# Did you know?

# Thought's from the Second Vice District Governor:

Whenever I see or hear a quote, whether it is a famous quote or not, that strikes me I always try to keep a copy of it. One of the quotes that has been sticking with me lately is from Johann Wolfgang von Goethe. He was a German writer, artist and politician who lived from 1749 to 1832. A German writer who lived back then is probably causing some of you to tune out, but try and stick with me. It is a great quote. Johann wrote the following,

"I have come to the frightening conclusion that I am the decisive element. It is my personal approach that creates the climate. It is my daily mood that makes the weather. I possess tremendous power to make life miserable or joyous. I can be a tool of torture or an instrument of inspiration, I can humiliate or humor, hurt or heal. In all situations, it is my response that decides whether a crisis is escalated or de-escalated, and a person is humanized or de-humanized. If we treat people as they are, we make them worse. If we treat people as they ought to be, we help them become what they are capable of becoming."

The reason I love this quote is how empowering it makes us all out to be. We control the world around us. It is our decisions that shape our environment and the lives that we touch. It is awesome thinking of that absolute power we each hold. On the other hand, this quote can actually be quite scary. My family, the people I work with, my fellow Lions; their environments are all shaped and constantly reshaped by my mood, my decisions, and my words. It is frightening to think that when we might be having a bad day or being negative, then we are altering everyone's world we come in contact with.

Now if you've stuck with me this far, you might be wondering why I'm writing about this quote in our newsletter. It is because I have recently seen a few instances of "but we've always done it that way" in Lions, in my work and in my personal life. Things that were brought up by people who had enthusiasm, but someone else's daily mood quickly changed the weather. I could be alone in seeing these instances, I hope I am. But if I'm not and you happen to witness an idea being turned away simply because it is a new project or it isn't the way something is normally done, talk to the person. Offer assistance if possible or advice on their idea. If you are a leader get more information from them. There are many valid reasons why a new projects or ideas can't be taken on. This could be because of lack of funds, workers, etc. Just because it is a different or something new shouldn't be one of them.







### **NOMINATIONS**

The completed application form(s), will be provided to the Chairman of the District Governor's Honorary Committee. Said application may be made by any Lion in the District that is in good standing. The application(s) are required to be received by February 28th of each year and will be valid for that year only. If an applicant is not selected for that year, a new application must be submitted again to be considered for this award. There is no requirement to induct someone each and every year.
